Exhibition Details and Guidelines - Please read this prospectus carefully.

Eligibility: Open to all active (paid-up) signature members of PSNJ working in soft pastels (no oil pastels) to participate in this show. All entries must be predominately (80%) executed in soft pastels. Only **original** work, executed within the past five years and not previously exhibited in a PSNJ judged Show is eligible. All entries must be original, and created independently by the artist from his/her own original reference materials or setup. Work done in a classroom setting or workshop, under the guidance of an instructor or with an instructor present, is not eligible. Work may not be based on or directly derived from reference materials created or arranged by others, even if with permission, royalty-free, or not copyrighted. Entry Requirements: All work including frames, cannot be less than 12" or exceed 36" in either dimension. Work must be framed in a professional manner with secure brackets & sturdy, taut wire. No saw-tooth hangers. Metal frames are not acceptable.

Fees: \$30, non-refundable, for 1 painting. The MPAC will take a 20% commission on any sales.

Registration: Mail the signed pre-registration form, with your check, payable to PSNJ for \$30. Pre-registration must be postmarked and digital images submitted (see Pg. 3 for instructions) by March 15, 2019.

Entries: Each artist may submit 1 piece. Paintings juried into this show will count towards the artist's Distinguished Signature Membership (D-PSNJ) status.

Reception: Saturday, April 14, 2017, 3pm – 5pm. Awards will be presented at 4pm.

Your image must be **300 dpi with the longest side 1200 pixels**. Please name your image as follows: last name_first initial_title of painting.jpg. Ex: Gladstone_A_Lingering Light.jpg

Follow these 5 simple steps:

2. Drag your image to the browser window (easiest method), or you can also use the blue "Choose files" button to locate and select your image on your computer.
