Exhibition Details and Guidelines: Please read this prospectus carefully.

Eligibility: Open to all current paid-up signature members working in soft pastels. All entries must be original, and not done from published photography, executed within the past five years and not previously exhibited in a PSNJ Members Show or special exhibition. Work must be properly framed and wired (no saw-tooth hangers). PSNJ reserves the right to turn away any work unsuitably presented. If there is a question about eligible works, potential exhibitors should inquire prior to registration by contacting Anita Gladstone, Chairperson at 201-341-8852 or Stephanie Cook, Co-Chair at 201-741-3347.

Entry Requirements: All work including frames, cannot be less than 12" or exceed 40" in either dimension. Work must be framed in a professional manner with secure brackets & sturdy, taut wire. No saw-tooth hangers. Metal frames are not acceptable.

Entries: Each artist may submit up to 3 pieces, only one acceptance per artist. All paintings must be registered online on ShowSubmit. Entries should show only the painting, no frame or mat.

Fees: \$30, non-refundable, for 1 painting. \$5 for each additional painting up to 3. PSNJ will take a 20% commission on any sales.

Receiving: Tuesday, April 18, 10:30am-12pm
